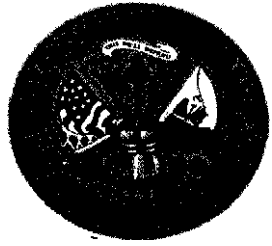

SUBJECT: Detainee Operations Update

- The Army is executing its Multifaceted Detainee Operations Action Plan that incorporates lessons learned from Guantanamo, Iraq and Afghanistan into its title 10 responsibilities. We believe that these actions are directly contributing to substantial improvement in the conduct of Detainee Operations. Reports of detainee abuse have decreased 80% from April through December 2004.
 - The Army is working with the Joint **Staff** and Deputy Assistant Secretary for Detainee Affairs to clarify policy and update doctrine. Specifically, we are revising DoD Directive 23 10.1, *DoD Program for Enemy Prisoners of War and Other Detainees*, and the Army Multi-Service Regulation AR 190-8, *Enemy Prisoners of War, Retained Personnel, Civilian Internees and Other Detainees*.
 - Detainee Operations lessons learned have been incorporated into all aspects of training. Integrated, realistic, scenario-based training is being provided to all Services, Army Components, and Army Functional Branches in both pre- and post- mobilization phases.
 - Force Structure redesign incorporates current combatant commander requirements and documents required changes in our future force structure.
 - Implementation of on-going design improvements to long-term detention facilities will increase force protection, provide economy for security operations, improve medical support, and improve quality of life for detainees.
 - Thorough investigation continues for every allegation of abuse. We received ten inquiries which led to five investigations of high profile senior level cases. Two of these investigations were unsubstantiated and are complete; three of these investigations are still ongoing.
- I look forward to briefing you on where we are and where we are going.

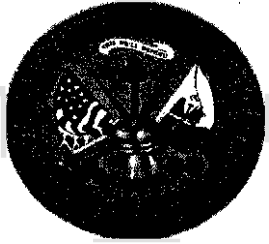

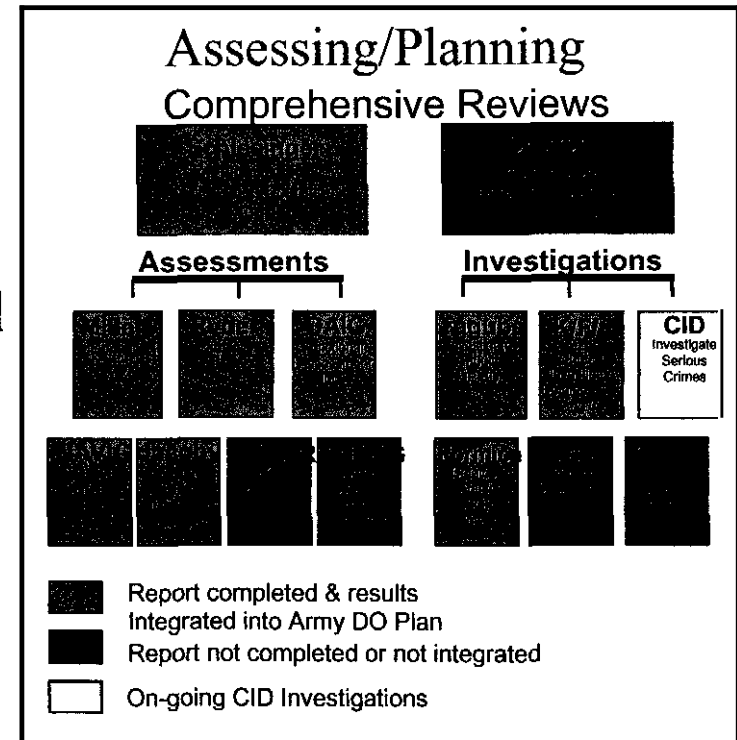

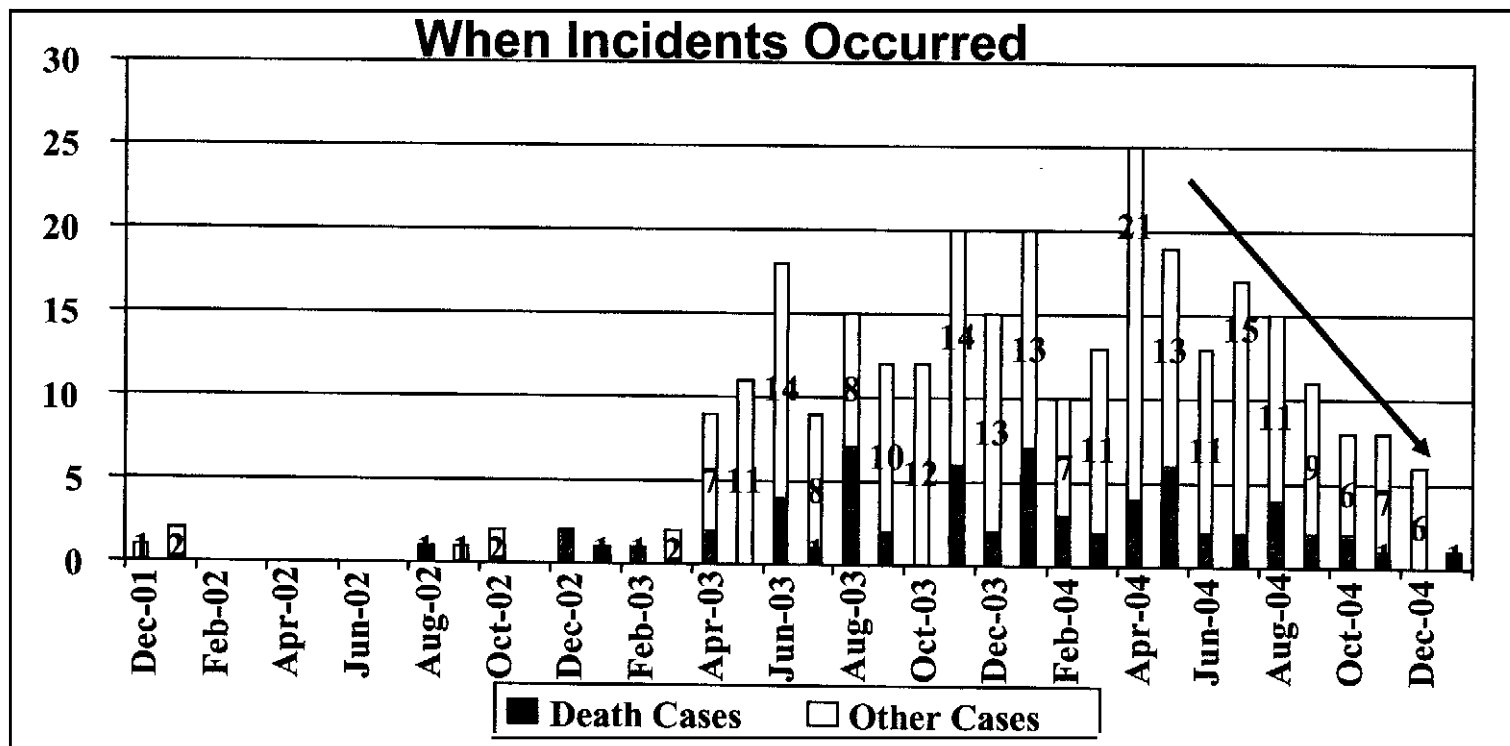
