MEMORANDUM FOR THE PRESIDENT

SUBJECT: DoD Support for Humcane Frances

A total of 6,310 Army and Air National Guard forces are in support of Hurricane Frances disaster relief operations. The State of Florida has 4,798 under the command and control of Governor Bush. Ten other state National Guards are providing an additional 1,512 personnel.

DoD actions include: deployment of a Defense Coordinating Officer and Defense Coordinating Element to Florida; deployment of an Emergency Preparedness Liaison Officer to critical military and civilian headquarters supporting response efforts; designation of four DoD installations as logistical staging areas for the Federal Emergency Management Agency; nurses to augment hospital staffs; satellite communications capability; airlift; and search and rescue teams. A detailed description is attached.

We will coordinate a formal after-action report through the interagency detailing the Department's participation in planning and recovery efforts. The intent **is** to identify "lessons-learned" which might be relevant to the Department's role in response and recovery from a catastrophic terrorist attack.

 Relevant issues might include mass casualty movement, protection of critical infrastructure, response to a civil disturbance, movement and distribution of critical life-sustaining resources in a contaminated environment and security during distribution of the Strategic National Stockpile medicines.

As Hurricane Ivan approaches, we will continue to work with DHS and the interagency to plan for its impact.
